5. Terms & Conditions

5.1 Period of Empanelment

The empanelment shall be valid for a period of 3 (three) years, however shall be extended based on performance and mutual agreement.

5.2 General

- ii. Empanelment is for individual companies/firms and no consortium will be considered for empanelment.
- iii. If information and details furnished are found to be false at any time in future or any information withheld, which comes to the notice of the organisation later, the organisation can de-empanel without any notice.
- iv. The Organisation reserves the right to call for additional information/ documents for verification in connection with assignment handled, as may be required as and when necessary, from time to time.
- v. The empanelment of the Business Associate shall be at the sole discretion of the organisation and the decision of the organisation shall be final and binding in all respects.
- vi. The empanelled Business Associate acknowledges that empanelment does not guarantee appointment or exclusive rights to assignments, and the Organisation may engage any expert at its discretion.
- vii. The empanelment also does not guarantee any minimum business to the empanelled expert consultant.
- viii. The empanelled Associates for a particular work/assignment shall not collaborate with any other lead business Associates for the same work/assignment or address the same work/assignment on its own.
 - ix. The empanelled Business Associate will be held responsible for the findings/ suggestions/ implications on the opinion undertaken by him/her for any overestimate, wrong estimate/ under estimate etc. therein and withholding any information and will be liable for action as deemed fit.

- x. The empanelled Business Associate, under no circumstances, will use any legend containing the GITCO's name or symbol on their letter heads, signboards, name plates, visiting cards etc., and will not use this empanelment to canvas the business.
- xi. The empanelled Business Associate confirms that the Associates / Director/ Promoter of the empanel firm/ Company/ agency have not been convicted for any offence and sentenced to a term of imprisonment by any court.

5.3 Fees for the assignment

The organization will fix the fees on a case-to-case basis, depending on the scope of work for each assignment. However, GITCO reserves the right to negotiate terms with the empanelled business associates prior to project initiation based on prevailing market standards.

5.4 Confidentiality

5.5 Intellectual Property Rights

5.6 Indemnity

Liquidated damages/penalties incurred on account of delay in completion of deliverable attributable to the associate shall be borne by the associate. All terms & conditions of the applied
